AGM MINUTES Saturday 5th January, 2013



Time opened: 7.40 pm

1. Minutes of previous meeting: Read by Mavis Jones, Secretary.

3. Presidents Report: Attached. Accolades and a vote of thanks to Don.

4. Finance and Audit Report: Ailcie McKenney – Treasurer.

Audit by Dot Ruck presented. Suggestion that our financial year from 1 October to 20 September could be tied in with Shire of Denmark's to avoid overlap was rejected as the Financial year for the Association is set in the Constitution.

Motion: that Dot Ruck be appointed Auditor for the next financial year.

7. General Business

7.1 Lease issue and ownership of buildings.

Don recapped on correspondence between the Progress Association and the Shire of Denmark on the lease anomaly which came to light in September due to a demolition application. The legal advice received brought into question the ownership of the cottages and created the current issue. On the 24th October, a delegation from the Association met with the Shire of Denmark with a view to address this situation. There was no outcome; however, the Shire indicated it will look to formulate a freehold policy for the leasehold at Peaceful Bay. An update from Dale Stewart said the proposed draft policy will be tabled for discussion at the Denmark Council meeting on 22nd January. Don said a delegation will attend this meeting and report back to the Committee.

Hayden Jones asked Cr Roger Seeney if the Council was aware of the fact that some leaseholders have taken out mortgages to purchase their cottages; and also the implications for financial institutions that hold these mortgages if the ownership issue remains unresolved. Roger was unable to answer with certainty and made a note to clarify with Council. Hayden said Council needed to consider existing mortgages in formulating a freehold policy so as not to create an unrealistic financial burden on leaseholders.

At this point, Cr Seeney informed the meeting that the Shire has a Customer Needs & Satisfaction Survey in progress which he encouraged ratepayers to complete and submit before 23rd January. It can be accessed through the Council's website or a hard copy can be obtained from the Denmark Shire Offices.

Tony Duckett and Greg Clark both spoke on the ownership issue and Tony reiterated that the Council is not seeking ownership but the anomaly needs be addressed and we need to be calm and not panic during the resolution process. The general consensus of the meeting was that we need a letter from the Shire of Denmark acknowledging that the leaseholders have ownership of their cottages.

7.2 Life Membership

Don proposed a Life Membership of the Peaceful Bay Progress Association for Ailcie McKenney in recognition of her work as Treasurer and her tireless contribution to the advancement of our community. The meeting agreed unanimously and applauded. Well done, Ailcie.

7.3 John Tuckett Acknowledgment

Dot Kleeman suggested we formerly acknowledge the work John had done in the Bay over the years.

<u>Motion</u>: That we acknowledge John Tuckett's contribution to our Committee and community over many years. It has been appreciated.

Moved: Dot Kleeman, 2nd: Tony Duckett - carried

7.4 Dust Issues

Baldy Matthews raised the issue of dust at his property on Fourth Avenue and asked about sealing the roads. John Meyers suggested a watering truck and Don said this had been looked at but was not viable. Dust suppressant has been investigated and found unsuitable. The Denmark Shire has indicated it is unable to consider bituminising unless there is a clear mandate from the residents of Second, Third, Fourth and East Ave. Don said a survey was carried out in 2009 on this issue. Of the responses received 70% were in favour of retaining the gravel roads and the main reason cited was that the gravel roads were an integral part of the natural appeal and charm of Peaceful Bay village. Don advised that residents experiencing problems with dust can follow Gregg Harwood's suggestion that non-potable water could be used to dampen the road with sprinklers or a hose. A comment was also made that an increase in speeding through the village could occur if bitumen was laid.

7.5 Fishing on Swimming Beach

Dot Kleeman informed the meeting that several swimmers have been abused and upset by fishermen at the swimming beach. As the sign provided by the Denmark Council has logos that indicate *surfing*, *fishing* and *swimming* it is felt that fishing creates a hazard for swimmers along with abandoned hooks and tackle in the sand.

Motion: that fishing be disallowed at the swimming beach.

Moved: Dot Kleeman, 2nd Janine Phillips - carried

7.6 Fire Safety

Dale Douglas said that in view of recent fires he was concerned there is only 1 road in and 1 road out of Peaceful Bay. A suggestion was to promote the Western Power track. <u>Motion</u>: that the Committee investigate alternative evacuation from Peaceful Bay other than Peaceful Bay Road.

Moved: Dale Douglas, 2nd: Greg Gibellini - carried

7.7 Fifth Avenue Roundabout

Roseanne Constant is concerned that people are going around the roundabout the wrong way and asked can the sign be more centred and cleared so it is more visible. Don will follow this up.

7.8 Horses on Beach Access Track

Resident was confronted by two horses on the beach access track and found there was little room to move and asked if it was allowed or should horses access the beach from the vehicle access road further up. Don said he had spoken to Gregg Harwood about this matter and was told horses can be ridden anywhere without restriction, also there is no law requiring horse owners to clean up their horses manure from public areas.

7.9 Committee Meeting Day

Hayden Jones asked if the Committee Meetings could be held on a weekend or maybe evenings rather than a Monday so that anyone who was still in the workforce and interested in serving on the committee could nominate. Don replied that the meeting day was decided by each new committee at the first meeting as per the Constitution of the Association..

The numbering of our cottages in both Freehold and Leasehold areas has come to the fore as on New Year's Ever a reported heart attack had Police running and down the streets with their flashing light on to see if they could find where the person was. Cycle paths will progress this year up to Peaceful Bay Road with the remainder to the beach access steps to the completed in 2014.

The 20kph signs are in place at the entrances to the leasehold area. Please remember our kids and drive with care. It only takes 30 seconds longer to travel from one end of the settlement to the other at 20kph.

A defibrillator was offered to the Association and will be housed at the Community Hall. When this arrives, we will put phone numbers in our Committee Meeting minutes as to how this can be accessed.

Removable bollards have been installed between 4th and 5th Avenues on East Avenue to allow residents at the end of 5th Avenue a second exit. Fire brigade keys allow access and will remove bollards if or when fire is reported this area. A controlled burn of land north of Flag Hill is scheduled for autumn this year.

Synergy Bills: Committee members have been alerted to a number of Synergy bills that have displayed incorrect meter reading and possibly faulty meters, so members are advised to check their usage (units) and charges on these bills and contact Synergy if discrepancies are detected.

Congratulations to Michael and Dee Thorp for being awarded the Pride of Australia Bravery Award at a ceremony in Perth recently. Michael and Dee assisted the brother of a trapped 16-year-old girl and helped them save her live just before the wreck caught fire.

Finally, Ron and Gwen Anning, two of our long-time residents and committee members have left the Baya. We were invited to the Walpole Country Club on the 28th October to participate in their farewell on behalf of the committee the people of Peaceful Bay. We extend to them our appreciation for the contribution they have made to the Bay.
